

### WALMART DE MÉXICO Y CENTROAMÉRICA REPORTS JUNE 2015 SALES

FREE TRANSLATION, NOT TO THE LETTER

Mexico City, July 6, 2015

Wal-Mart de México, S.A.B. de C.V. (BMV: WALMEX) announces to its shareholders as well as to the public in general that during the month of June 2015, sales amounted to **\$37,130 million pesos**. This figure represents an **8.1%** increase over sales reported in the same month of 2014.

#### Mexico Sales

During June 2015, total sales for Mexico increased **5.5%** over sales reported in June 2014. Comp store sales during the month, meaning all those units in operation for over a year, posted a **3.6%** increase compared to the same month of 2014.

Considering the **five-week period** from **May 30 to July 3, 2015**, as compared to the five-week period ending July 4, 2014, total sales increased **7.7%** and comp store sales increased **5.7%**.

The average ticket at our stores during the month of June experienced a **4.1%** increase in comp units, and the number of transactions had a **0.5%** decrease as compared to the same month of 2014.

### Central America Sales

During June, total sales for Central America, on a constant currency basis, increased **3.2%**, and comp store sales posted an increase of **0.6%**.
