

WALMART DE MÉXICO Y CENTROAMÉRICA REPORTS JULY 2015 SALES

Mexico City, August 5, 2015

Wal-Mart de México, S.A.B. de C.V. (BMV: WALMEX) announces to its shareholders as well as to the public in general that during the month of July 2015, sales amounted to **\$38,151 million pesos**. This figure represents an **11.0%** increase over sales reported in the same month of 2014.

Mexico Sales

During **July 2015**, total sales for Mexico increased **7.9%** over sales reported in July 2014. Comp stores sales during the month, meaning all those units in operation for over a year, posted a **6.0%** increase compared to the same month of 2014.

Considering the **four-week period from July 4 to 31, 2015**, as compared to the four-week period ending August 1, 2014, total sales increased **7.3%** and comp store sales increased **5.4%**.

The average ticket at our stores during the month of July experienced a **6.0%** increase in comp units and the number of transactions at our stores was equal to last year's.

Central America Sales

During July, total sales for Central America, on a constant currency basis, increased **6.1%**, and comp store sales posted an increase of **3.9%**.
