

WALMART DE MÉXICO Y CENTROAMÉRICA REPORTS NOVEMBER 2012 SALES

Mexico City, December 10th, 2012

Wal-Mart de México, S.A.B. de C.V. (WALMEX) announces to its shareholders as well as to the public in general that during the month of November 2012, sales amounted to **\$37,758 million pesos**. This figure represents an **8.9%** increase over sales reported the same month last year.

Mexico Sales

Total sales for Mexico increased **9.8%** over sales reported for the same month last year. Comp store sales during the month, meaning all those units in operation for over a year, posted a **5.5%** increase compared to the same month of 2011.

Considering the **four-week period** from **October 27th to November 23rd 2012**, as compared to the four-week period ending November 25th, 2011, total sales increased **11.5%** and comp store sales increased **6.8%**.

Average ticket at our stores had an 8.2% increase in comp units in **November** and transactions had a 2.6% decrease as compared to the same month of 2011.

Central America Sales

Total sales for Central America, on a constant currency basis, increased 7.8%, and comp store sales posted an increase of 3.2%.

Openings

In **November**, we opened 38 units:

- **Three Mi Bodega Aurrerá**, one in Acatlán and one in Tepatitlán, Jalisco and one in Nuevo Ideal, Durango.
- **One Walmart** in Querétaro, Querétaro.

Repurchase of Shares

From January 1st to November 30th 2012, we have invested **\$674** million pesos in the repurchase of **17,284,540** Company shares.
