(WALMEX) announces to its shareholders as well as to the investing public that Gian Carlo Nucci, currently executive vice president and COO of Walmart de México, has been named President and CEO of Walmart Chile, replacing Enrique Ostalé, who was promoted to President and CEO of Walmart Latin America, replacing Eduardo Solórzano. These changes will be effective March 1, 2013. Eduardo Solórzano will continue to serve as chairman of the Board of Directors of Walmex, position he has held since January 2010.
